#### SUPERVISOR'S REPORT

### May 2023 Town Board Meeting Supervisor's Report

- 1. I reviewed the credit card monthly charges and found no issues.
- 2. James P. Rusak was recently appointed to the position of Regional Director of the NYSDOT Region Nine Sector. I am looking forward to working with him.
- 3. We received our 1<sup>st</sup> quarter sales tax check in the amount of \$278,675.86. Sales tax in New York State is around 7% higher compared to the same time last year.
- 4. We also received our first quarter check from the Broome County Jail for \$21,731.32 plus the Annual Lump Sum check based on the CPI, for \$51,277.82

- 5. From Assemblyman Joe Angelino to Mandy Fallon, NYS Leg. Clerk regarding our request for a **Hotel Occupancy Tax**: Since my email to you back in March, I had to amend the bill below A.2640 for the Town of Dickinson to change the years from 3 to 2 years since the Senate is only doing 2-year timeframes. Attached are the amendments. Would you please let me know if Senator Webb is interested in carrying the same bill in the senate? Thank you.
- 6. Commissioner Kie informed me that he and Town Engineer Ron Lake, met with Delta Engineer President, Anthony Pannicia who is also a member of the SUNY Broome Board of Trustees to go over plans to work on the John St. drainage issue once the county/SUNY Broome takes over the Boland Property.
- 7. Received a message from Bill Sands, member of the Town Planning Board, requesting that the NYSDOT review and lower present speed limit on the new Front St. bridge which is currently 45 mph. Install Rotary sign on Front St. heading north from Bevier St. to first rotary. And concerned that pedestrians often do not use the designated crosswalks and instead, J walk across the traffic lanes in various locations by the traffic circle. I forwarded their concerns to the Regional Director.
- 8. The next BCATV meeting is scheduled for May 25, 6:00 PM, at the Little Venice Restaurant. The 2023 officers will be taking the Oath and will be administered by NYS Supreme Court Justice Oliver Blaise. Guest speaker Steven Franklin, the General Manager of Dick's House of Sports, will be discussing the new complex coming to the Oakdale Commons in Johnson City.
- 9. I asked our Town Assessor to investigate the information that we received from our fire department regarding undervalued utility properties. Jack discovered that those properties were undervalued and had made the changes that will take effect next year. There will be at least \$6-\$7 K added to the fire district next year.
- 10. There will be a Court Clerk's meeting on Monday, May 22, 9 am, in the Court Room for NARCAM Training by the NYS DOH. Just show up if you are interested in attending.

#### **PUBLIC COMMENTS**

#### A resident has 2 concerns:

- O She was concerned about the increase in her water bill. Her water bills in the last 2 or 3 years have been roughly a total of \$30.00, which includes the \$15.00 surcharge. Her current bill is now raised \$50.00 for surcharge plus their water usage. Councilperson Morabito explained that the \$50.00 is for a service charge to repair the water lines as everything has gone up in price, material, labor etc. not for water usage. The town is not making any money from this increase, it is just to cover the costs of doing the repairs in the Town of Dickinson. Supervisor Marinaccio explained that every year we will review where we are at with billing and if we can decrease the billing to residents we will try and do that.
- She was also concerned with **The BASAI** playing field with them adding lights and making it a turf field. Her concern was the runoff going into the Cutler Pond and also the noise from the fields. Evenings and weekends she would like to be outside in her yard and not hear dogs barking and girls playing softball. Supervisor Marinaccio explained he knows very little about the schedule that will take place at the fields. He could not comment on it any further until he had more information. She recommended a sound barrier. Supervisor Marinaccio is going to reach out to Brenda Gow with her concern.

#### **PUBLIC COMMENTS CONT'D:**

A second resident was concerned about his water bill also. He believes the more water used, the more their surcharge should be rather than charging every resident the same fee. The board is going to review his comments and maybe add some break off points on how much each household is using.

**NOW THERFORE, BE IT RESOLVED** by the Town Board of the Town of Dickinson as follows:

**RESOLVED** that the Town Board hereby declares itself lead agency pursuant to SEQRA for this action, finds and concludes that the proposed action is a Type I action within the meaning of 6 NYCRR 617.4 and therefore is subject to review under SEQRA and the regulations thereunder, and determines that the review is a coordinated review; and be it further

**RESOLVED** that because this action is an amendment of the Town's local laws, no other agencies are interested or involved parties to this action; and be it further

**RESOLVED** that based upon an examination of the Full Environmental Assessment Form and other available supporting information, and considering both the
